	on 2022-23 with the annual Band D charge rising from £27.51 in 2022-23 to £30.13 in 2023-24.		
	Resolved: That the proposed budget for 2022/2023 be agreed at £61,967 with a resulting precept of		
	£60,413. This an annual increase of 9.5% or £2.62 on a band D property.
